

## **End-User License Agreement**

This End-User License Agreement (“EULA”) is a legal agreement between you (either an individual or organization) and TEL.RED, LLC for Sky software, which includes this computer software and its associated printed and online documentation (“SOFTWARE PRODUCT”). ### **GRANT OF LICENSE**

### **USAGE**

This EULA grants you no rights to USE materials owned by other copyright holders. ## LIMITED WARRANTY

## LIMITATION OF REMEDIES

TEL.RED, LLC's entire liability and your exclusive remedy shall be, at TEL.RED, LLC's option, either (a) return of the price paid not including shipping and handling within 90 days or (b) repair or replacement of the SOFTWARE PRODUCT within 90 days. Any replacement SOFTWARE PRODUCT will be warranted for the remainder of the original warranty period.
